FLOWERS: Nantucket Cake Company will place and arrange your flowers on the cake as well as around the base of the cake. All flowers need to be fresh, unless you would prefer us to supply handcrafted gum paste sugar flowers at a cost. All flower arrangements must be available to us on the day of the wedding.
